## Objectives and investment policy

### Objectives

To seek a return exceeding that of a bond investment in EUR.

### Investment policy

At least two thirds of the sub-fund is invested in fixed-rate and/or variable debt securities.

The sub-fund may also achieve this objective by investing at most 30% of its net assets in investment funds.

Investments are made without any geographical or sector-based restrictions.

Debt securities may be issued by companies, states and/or other entities. Neither these securities nor their issuers are subject to any ratings requirements.

The portfolio is managed on a discretionary basis without using a reference

benchmark.

The currency of the share class is expressed in EUR.

The investor has the right to redeem his shares on demand. The dealing in shares is carried out on each complete bank business day in Luxembourg. The attention of the investor is drawn to the fact that in exceptional circumstances, the possibility for the investor to request the redemption of his shares may be limited or suspended.

These shares are distribution shares. Income and capital gains are distributed.

### Recommendation

This fund may not be appropriate for investors who plan to withdraw their money within 3 years.

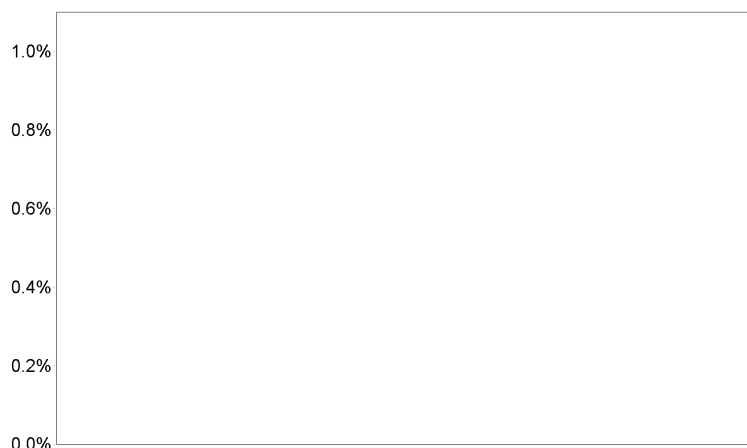
