Objectives and Investment Policy

The objective of the Fund is to achieve long term capital growth.

The Fund is actively managed, mainly investing in convertible bonds or similar financial instruments issued by companies from around the world. In addition, the Fund may hold bank deposits as well as invest in other funds or money market instruments. In order to achieve its objectives, the Fund may use derivatives to reduce the impact that the currency exchange rates and market changes might have on the Fund's performance.

In principle you can sell shares of the Fund once a week on a bank business day. Income remains in the Fund and is reinvested.

This risk and reward indicator illustrates where the Fund is positioned in terms of its possible risk and reward. The higher the Fund's position on this scale, the greater the possible reward, but also the greater risk of losing money. This risk indicator is calculated using historical data, which cannot be used as a prediction for the future. Therefore the risk classification may change over time. Even if the Fund is in the lowest risk class you can lose money, as no investments are entirely risk free. The risk and reward indicator has been calculated using simulated historical performance data, which may not be a reliable indicator of the Fund's future risk and reward profile.

This Fund is in category 4 since the price changes of the Fund have been moderate in the past.

Counterparty risk: The Fund enters into contracts with various counterparties. If a counterparty does not fulfil its obligations to the Fund (e.g. not paying an agreed amount or not delivering securities as agreed) the Fund can suffer a loss.



*The performance fee is equal to 10% of any return above the Fund's net asset value per share at the end of the previous calendar year (High Water Mark). The Fund pays the performance fee on an annual basis.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it.
