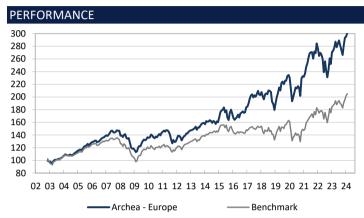

FUND MANAGER'S COMMENTS

After a positive January, the month of February closed in the same vein. The Eurostoxx 50 index (SX5P) ended the month with an increase of +1.54%, and our fund with an increase of +2.07%. We see that the markets have been carried away by a wind of optimism thanks to convincing corporate results and the striking figures for American growth.

During this month, the composition of our portfolio remained unchanged.

Outlook: Now that the results season is almost coming to an end, investors will have to wait until March 7 to analyse the Fed Chair's speech on inflation and his next measures regarding lowering key rates. As for the ECB, which will also meet on the same day, is expected to keep its rates unchanged. As far as we are concerned, we remain constructive on equities which are still based on solid prospects. Our focus on quality stocks remains unchanged.

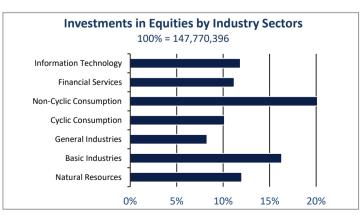
