FUND MANAGER'S COMMENTS

In April, the fund declined by 2.88% to EUR 247.17

In a context of geopolitical uncertainty, inflation and rising interest rates, all risky assets have corrected. However, the earnings season was a supporting factor, particularly in the United States. On average, American companies published results 5% above expectations, compared to 6% in Europe. If analysts' expectations are very high for the largest capitalizations exposed to artificial intelligence, this is not the case for the rest of the stock.

Europe - The ECB once again affirmed that its monetary policy does not depend on the Fed. Thus, the market now anticipates action by the ECB before the Fed and 3 rate cuts by the end of the year. On the business side, German **SAP** published results above expectations. Despite the Chinese slowdown, L'**Oréal** published turnover beyond forecasts. Sales increased by +12.6% in Europe and +12.3% in the United States. **Roche** published disappointing quarterly figures following the drop in sales of Covid-related products. **Novartis** announced quarterly results above expectations and raised its ambitions for 2024. **Nestlé** saw its sales decline in the first quarter of 2024. The results came in below expectations. However, the company remains confident and maintains its objectives. **Straumann** saw its revenues increase in the first three months of 2023, beyond forecasts. This, in particular due to outperformance in the Asia-Pacific region. However, sales in North America indicate a slowdown.

United States - The persistence of high interest rates is also reflected in the latest data from the industrial activity index, the latter has fallen below the economic expansion threshold of 50 points. On the business side, the results of **Google**, which is initiating a dividend for the first time, are well above expectations, notably through stronger growth in activity. The same goes for **Microsoft**, which notably shows growth of 31% in its "Azure" Cloud division. **Meta**'s results disappointed investors due to a less encouraging outlook. These publications confirmed that the investment cycle in Al equipment is still ongoing, stronger than expected. **Amazon** reported strong first-quarter results, driven by its "AWS" cloud unit and new advertising revenue generated by its Prime Video streaming service. **Activity** -

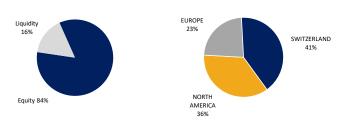
